

# Electronic Health Record (EHR) Instructions for the iKnowMed® EHR System:

**Create a list of patients** with very low- to intermediate-risk MDS and a recent hemoglobin result and who are not previously treated with ESA agents or REBLOZYL (luspatercept-aamt) in iKnowMed® EHR systems

## INSTRUCTIONS FOR CREATING A REBLOZYL PATIENT LIST

The below instructions are designed to help identify patients with very low- to intermediate-risk MDS and a recent hemoglobin result and who are not previously treated with ESA agents or REBLOZYL.

### Instructions and Limitations

These instructions are created specifically to create a REBLOZYL Patient List in iKnowMed EHR systems and will not work for other conditions, treatments, and therapeutic areas.

The process outlined in this piece is variable, and not all steps will apply to every health system. Any steps or settings that are not part of a health system's standard process should be excluded or modified accordingly. Any questions should be directed to the appropriate service provider. The practice is solely responsible for implementing, testing, monitoring, and ongoing operation of any EHR tools.

### The criteria for the patient query are:

- A documented diagnosis of Myelodysplastic Syndromes using ICD-10 code from the list below:
  - **D46** Myelodysplastic syndromes
    - **D46.0** Refractory anemia without ring sideroblasts, so stated
    - **D46.1** Refractory anemia with ring sideroblasts
    - **D46.A** Refractory cytopenia with multilineage dysplasia
    - **D46.B** Refractory cytopenia with multilineage dysplasia and ring sideroblasts
    - **D46.4** Refractory anemia, unspecified
    - **D46.Z** Other myelodysplastic syndromes
    - **D46.9** Myelodysplastic syndrome, unspecified
- Lab result for hemoglobin (Hgb): <10 g/dL
- Medications:
  - **Not** previously treated with ESA (erythropoiesis-stimulating agent, ie, epoetin alfa and darbepoetin alfa) medications
  - **Not** previously treated with REBLOZYL (luspatercept-aamt)

Consider including a display column in the report with hemoglobin (Hgb) data to evaluate changes in volume from the baseline reading. Once patient is identified, a further assessment can be scheduled.

**Note:** Consider running the report on a regular basis. Once the initial report has been created, it can be saved for future use and subsequent reports can be re-run. Running reports over time helps identify new patients meeting the inclusion criteria and see progression or worsening of existing patients.

## INDICATIONS

REBLOZYL® (luspatercept-aamt) is indicated for the treatment of anemia without previous erythropoiesis stimulating agent use (ESA-naïve) in adult patients with very low- to intermediate-risk myelodysplastic syndromes (MDS) who may require regular red blood cell (RBC) transfusions.

REBLOZYL® (luspatercept-aamt) is indicated for the treatment of anemia failing an erythropoiesis stimulating agent and requiring 2 or more red blood cell (RBC) units over 8 weeks in adult patients with very low- to intermediate-risk myelodysplastic syndromes with ring sideroblasts (MDS-RS) or with myelodysplastic/myeloproliferative neoplasm with ring sideroblasts and thrombocytosis (MDS/MPN-RS-T).


REBLOZYL is not indicated for use as a substitute for RBC transfusions in patients who require immediate correction of anemia.

## SELECTED IMPORTANT SAFETY INFORMATION WARNINGS AND PRECAUTIONS

### Thrombosis/Thromboembolism

In adult patients with beta thalassemia, thromboembolic events (TEE) were reported in 8/223 (3.6%) of REBLOZYL-treated patients. Patients with known risk factors for thromboembolism (splenectomy or concomitant use of hormone replacement therapy) may be at further increased risk of thromboembolic conditions. ## iKnowMed:

The Practice Insights reporting solution, or the User Library reports can be used to create a patient list in iKnowMed. In both cases, two individual reports need to be created and the results exported to Excel to filter patient with very low- to intermediate-risk MDS, a recent hemoglobin result and are not previously treated with ESA agents or REBLOZYL.

The first step is to run a list of patients with the diagnosis ICD-10 codes. Next, run a report with patients using REBLOZYL and/or ESA (erythropoiesis-stimulating agent, ie, epoetin alfa (Epogen, Procrit, Retacrit) and darbepoetin alfa (Aranesp) medications and hemoglobin (Hgb) results. Finally, merge the results of both reports in Excel based on the suggested logic, including patients with the diagnosis with hemoglobin results, but not previously treated with ESA agents or REBLOZYL.

### Step 1: Run the Diagnosis report

1. Click **User Dashboard > Library**
2. Launch the **Diagnosis Report reporting template**
3. Click **Create List** to create a new list
4. Enter and select the **MDS ICD codes** listed in the Instructions and Limitations
5. Click **Search** to launch the patient query
6. **Save** the results and **export to Excel**

### Step 2: Run the Patient List report

1. Click **User Dashboard > Library**
2. Launch the **Patient List reporting template**
3. Click **Create List** to create a new list
4. Enter and select **ESA (erythropoiesis-stimulating agent, ie, epoetin alfa (Epogen, Procrit, Retacrit) and darbepoetin alfa (Aranesp)) medications and REBLOZYL** in the Medications filter
5. Enter and select **hemoglobin in the Lab Analyte filter** and set the range as desired
6. Click **Search** to launch the patient query
7. **Save** the results and export to **Excel**

### Step 3: Merge the results in Excel

1. In Excel, **merge both reports using a primary key**, for example the MRN
2. Set the logic to:
  - a. Diagnosis of Myelodysplastic Syndromes  
**AND**
  - b. Lab result for hemoglobin (Hgb): set the desired result range (<10 g/dL)  
**AND NOT**
  - c. Previously treated with ESA
  - d. previously treated with REBLOZYL
3. **Save** the report with a **unique name** (for example “*First-Line (1L) MDS patients*”)
4. For patients that meet the logic, review the chart and evaluate the patient’s hemoglobin result (Hgb)

**ACTION:** Share report results with prescribers to prompt patient evaluation for potential need for anemia symptom management. Consider the patient’s transfusion data and hemoglobin levels as part of the patient evaluation (data specific to transfusions and hemoglobin may be available in lab results, a flowsheet and past procedures).

## IMPORTANT SAFETY INFORMATION

### WARNINGS AND PRECAUTIONS

#### Thrombosis/Thromboembolism

In adult patients with beta thalassemia, thromboembolic events (TEE) were reported in 8/223 (3.6%) of REBLOZYL-treated patients. TEEs included deep vein thrombosis, pulmonary embolus, portal vein thrombosis, and ischemic stroke. Patients with known risk factors for thromboembolism (splenectomy or concomitant use of hormone replacement therapy) may be at further increased risk of thromboembolic conditions. Consider thromboprophylaxis in patients at increased risk of TEE. Monitor patients for signs and symptoms of thromboembolic events and institute treatment promptly.

#### Hypertension

Hypertension was reported in 11.4% (63/554) of REBLOZYL-treated patients. Across clinical studies, the incidence of Grade 3 to 4 hypertension ranged from 2% to 9.6%. In ESA-refractory or -intolerant adult patients with MDS with normal baseline blood pressure, 26 (30%) patients developed systolic blood pressure (SBP)  $\geq 130$  mm Hg and 23 (16%) patients developed diastolic blood pressure (DBP)  $\geq 80$  mm Hg. In ESA-naïve adult patients with MDS with normal baseline blood pressure, 23 (36%) patients developed SBP  $\geq 140$  mm Hg and 11 (6%) patients developed DBP  $\geq 80$  mm Hg. Monitor blood pressure prior to each administration. Manage new or exacerbations of preexisting hypertension using anti-hypertensive agents.

#### Embryo-Fetal Toxicity

REBLOZYL may cause fetal harm when administered to a pregnant woman. REBLOZYL caused increased post-implantation loss, decreased litter size, and an increased incidence of skeletal variations in pregnant rat and rabbit studies. Advise pregnant women of the potential risk to a fetus. Advise females of reproductive potential to use effective contraception during treatment and for at least 3 months after the final dose.

### ADVERSE REACTIONS

#### ESA-naïve adult patients with Myelodysplastic Syndromes

Grade  $\geq 3$  ( $\geq 2\%$ ) adverse reactions included hypertension and dyspnea.

The most common ( $\geq 10\%$ ) all-grade adverse reactions included diarrhea, fatigue, hypertension, peripheral edema, nausea, and dyspnea.

#### ESA-refractory or -intolerant adult patients with Myelodysplastic Syndromes

Grade  $\geq 3$  ( $\geq 2\%$ ) adverse reactions included fatigue, hypertension, syncope and musculoskeletal pain. A fatal adverse reaction occurred in 5 (2.1%) patients.

The most common ( $\geq 10\%$ ) adverse reactions included fatigue, musculoskeletal pain, dizziness, diarrhea, nausea, hypersensitivity reactions, hypertension, headache, upper respiratory tract infection, bronchitis, and urinary tract infection.

### LACTATION

It is not known whether REBLOZYL is excreted into human milk or absorbed systemically after ingestion by a nursing infant. REBLOZYL was detected in milk of lactating rats. When a drug is present in animal milk, it is likely that the drug will be present in human milk. Because many drugs are excreted in human milk, and because of the unknown effects of REBLOZYL in infants, a decision should be made whether to discontinue nursing or to discontinue treatment. Because of the potential for serious adverse reactions in the breastfed child, breastfeeding is not recommended during treatment and for 3 months after the last dose.

### DRUG ABUSE POTENTIAL

Abuse: Abuse of REBLOZYL may be seen in athletes for the effects on erythropoiesis. Misuse of drugs that increase erythropoiesis, such as REBLOZYL, by healthy persons may lead to polycythemia, which may be associated with life-threatening cardiovascular complications.
